 - Junior Skating members who participate in synchronized ice skating and are aged under 18 years.
 - Aussie Skate members who participate in synchronized ice skating in an Aussie Skate (Skate School) team.
 - Non-Skating members (including Coaches and parent/guardians) who do not participate in synchronized ice skating, are aged 18 years or over and support the objectives of the Club.

Everyone applying to join or re-join the Club, or to renew their membership, must submit a Membership Application Form and pay the applicable membership fees. Membership applications are to be submitted to Team Managers.
